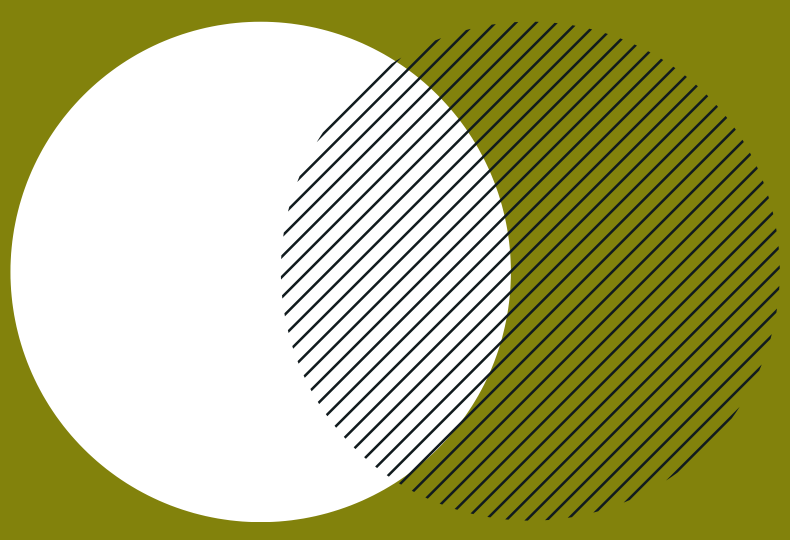

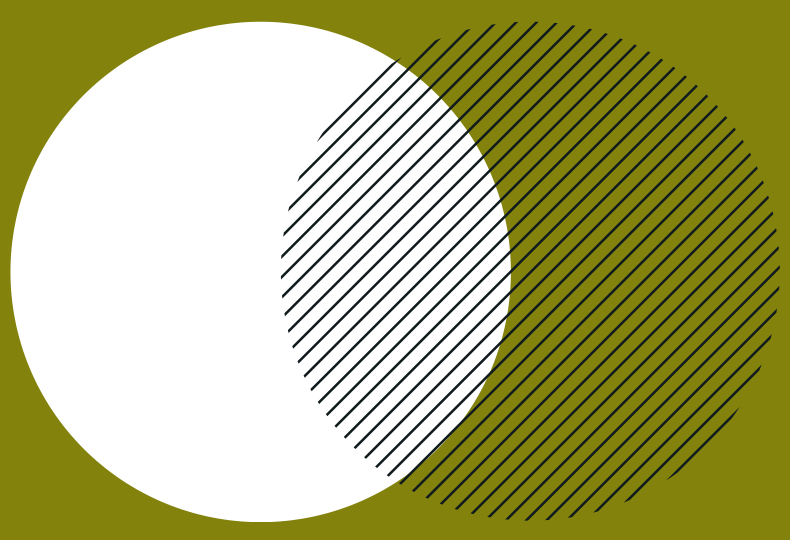

### BRANDING OPTIONS

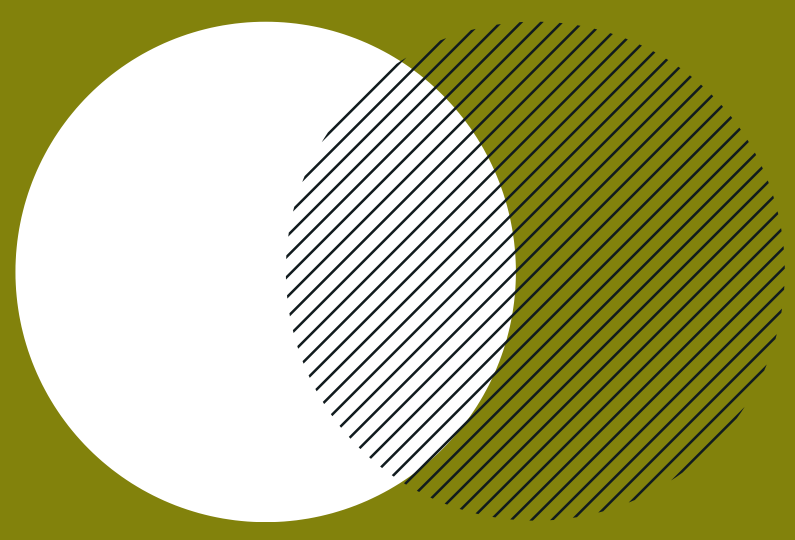
Allowed per Hole:

- Sponsor to manage setup/breakdown themselves (No charge – no table/chairs provided. We only deliver branding to the hole.)

Note: Branding left behind on the course will be charged at R500 per hole. Unclaimed branding will be stored for 30 days only.

## 4. BRANDING GUIDELINES & LOGISTICS

- Setup time on Golf Day: 07:00 – 09:00
- Branding may be delivered the day before the event, after 13:00.
- Early drop-offs during the week require special arrangements with the Events Manager.

### **Important:**

- Clearly label all branding: Company Name, Hole Number, Contact Details
- Hole sponsors arriving on the day must check in at Reception for assistance.
- Randpark can store branding one day in advance and guide you to your sponsored hole.
- Branding left behind will be discarded after 30 days unless collected.

## 5. COLLECTION OF BRANDING

- All branding (banners, gazebos, signage) must be removed after play ends.
- Randpark is not responsible for any items left overnight.

## 6. BEVERAGE ORDERS & TERMS

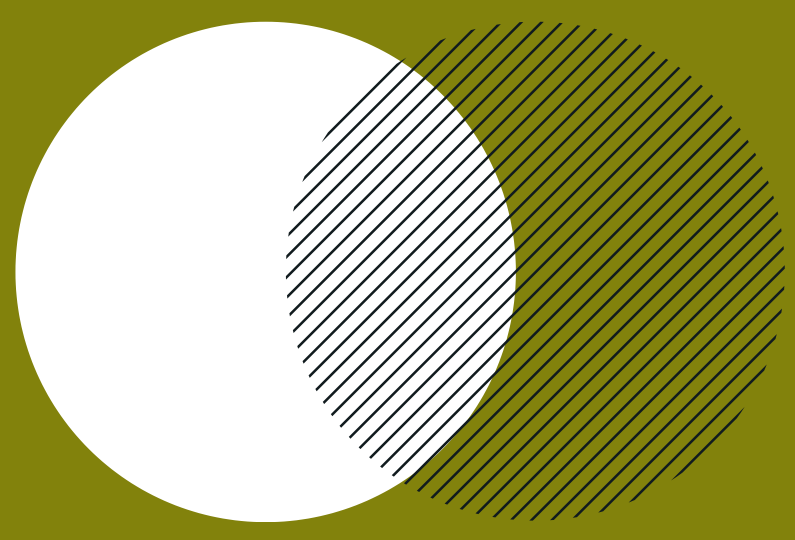
- Deadline: Orders and signed T&Cs must be submitted at least 5 days before the golf day.
- Drinks are for the sponsor's own account and sold by the case (24 units).
- No returns. Leftover stock can be taken home.
- An ice bath will be provided only for drinks purchased from Randpark.

### **Estimate:**

For a full field (120 players), budget around 8 cases (192 beverages). This includes extras for caddies.

### **Allowed Beverages:**

- From Randpark: Beer, Wine, Ciders, Coolers, Soft Drinks, Water
- Bring your own: Hard tack only (e.g. shooters)
- Bringing own beverages? Signed T&Cs required. Surcharge: R1350.

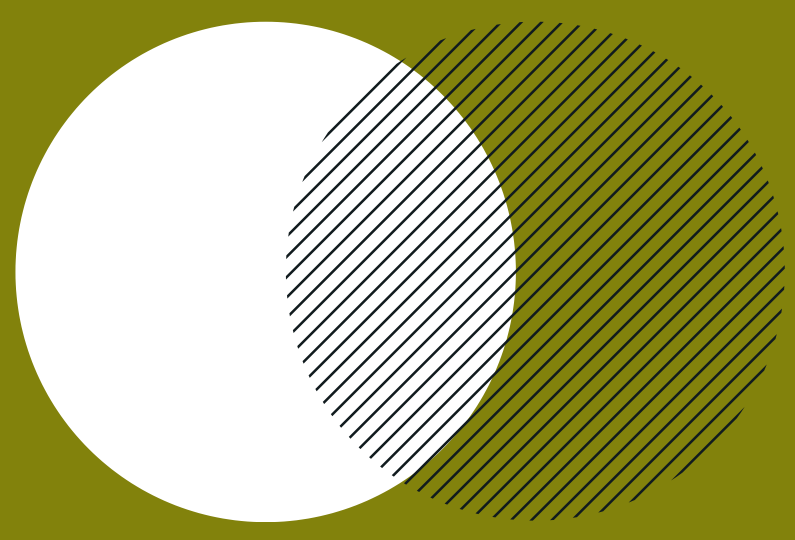

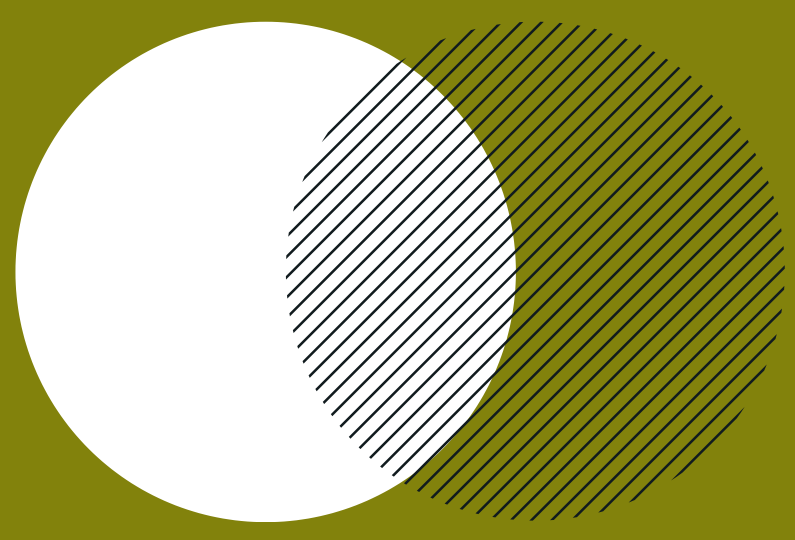

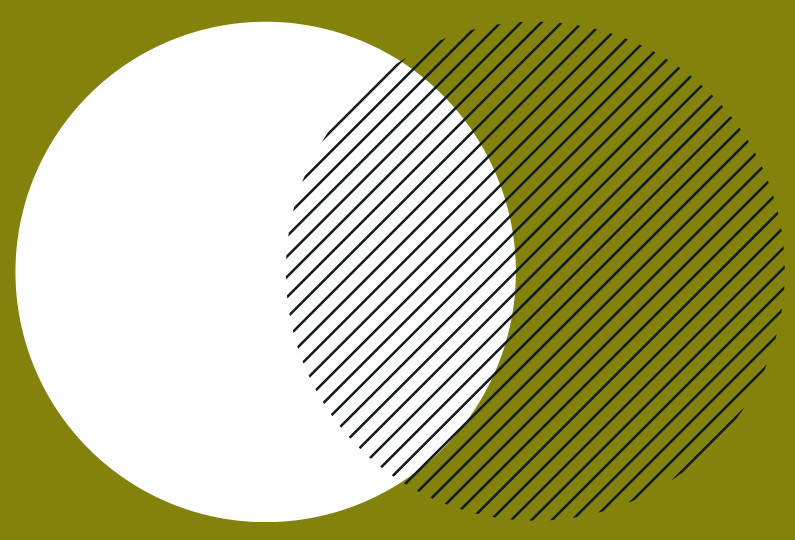
